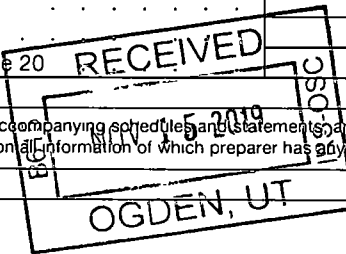

In 2018, the digital library for Haiti was filled with around 1,000 quality titles from local Haitian publishers and international publishers, available in Haitian Creole, French, English, and Spanish.
