Should an audit become necessary, Son Glow Ministries Inc will request the services of a professional accounting firm to perform the audit/audits. Upon completion of an audit, the audit committee consisting of the Board of Directors serving as the audit committee of the whole, would review the finding and recommendations contained in the report and implement action to correct/remedy negative practices.
