When determining whether or not the compensation of the Chief Executive Officer is reasonable, the Executive Committee considers all elements of compensation, compensation of Chief Executive Officers of full-facility YMCAs in Eastern Washington State, the YMCA of the USA recommended salary range for Chief Executive Officers of YMCAs with budget sizes similar to the Wenatchee Valley YMCA, and committee members' knowledge of compensation trends in North Central Washington. The Executive Committee process is documented in the committee minutes, in a letter to the Chief Executive Officer, and in a written report presented at the next regular meeting of the Wenatchee Valley YMCA Board of Directors. Documentation includes the date of compensation discussion, the compensation recommendation, the effective date of the action, committee members present, description of comparability data, and the action that the approved compensation recommendation is reasonable.
