St. Francis House provided food, clothing, and other basic necessities to the homeless and working poor in King County and Seattle, Washington. During 2018, St. Francis House provided, free of charge, \$8,865 of sleeping bags, \$17,322 of backpacks to the homeless. Additionally, St. Francis House provided \$12,911 of clothing/underwear/socks and \$3,516 of personal toiletries/toothbrushes/toothpaste/razers to the homeless and working poor. St. Francis House also provided \$11,697 in gas and groceries, \$5,274 in utilities assistance, and \$6,190 in transportation assistance. In 2018, St. Francis House served approximately 60 people daily, also providing hot beverages and sandwiches to another 50 people daily.
