Conservation of the endangered Snow Leopard and its mountain ecosystem In 2018 the Snow Leopard Trust worked with more than 5,500 rural, pastoralist households to implement programs that not only protect wild snow leopards but also improve the quality of life for herder families, including women and children Our programs were livestock insurance, livestock vaccination, corral-building, and a conservation handicraft program called Snow Leopard Enterprises As part of these programs herders signed Conservation Contracts in which they agreed to protect snow leopards and their key prey In turn, the programs provide economic and social support to herder families In 2018, women taking part in Snow Leopard Enterprises earned up to \$200 from handicraft sales and conservation bonuses Herders were able to insure over 11,000 livestock against snow leopard and wolf attacks, and over 100,000 livestock were vaccinated against disease We also provided 9 awards to honor rangers for apprehending illegal hunters The Snow Leopard Trust also continued its role as the lead technical advisor to the Global Snow and Ecosystem Protection Program (GSLEP) developed out of the 2013 Global Snow Leopard Forum The goal is to increase protection across 23 landscapes to support more than 2000 snow leopards by 2020

Education, awareness and capacity building for snow leopard conservation We provided environmental educational, skills-training, and outreach to adults and children In 2018, Over 1,400 children in snow leopard habitat took part in environmental education and outreach through nature clubs and eco-camps We helped teachers integrate environmental workbooks into their curriculum, and took children on eco-camps in the mountains in Mongolia, India, and Kyrgyzstan Eco-camps are experiential and hands-on learning consisting of an introduction to the snow leopard, biodiversity and food web, biological adaptations of generalist and specialist species, climate change, understanding greenhouse effect, human interaction with wildlife We supported over a dozen PhD students in 2018 with projects ranging from the first-ever snow leopard disease study to understanding impacts of climate change on snow leopard habitat We used mass media to raise awareness for snow leopard protection and held public Snow Leopard Day events in Mongolia and Pakistan In Mongolia, we also producing a newsletter that was sent to over 700 herders, government officials, and environmental managers

Research and monitoring of Snow Leopards and their environment In 2018, we continued our long-term snow leopard study in South Gobi, Mongolia to increase our understanding of snow leopard ecology, behavior, and habitat needs This study includes GPS collaring/tracking, trap camera surveys, prey surveys, data collection related to snow leopard disease and disease transmission, and assessment of livestock grazing impacts on the health and abundance of wild prey In 2018, we expand our camera trapping studies into new areas in India, Mongolia, and Kyrgyzstan as part of the first robust global snow leopard population assessment We were able to cover more than 10,000 km² of additional snow leopard habitat In Mongolia (Khorkh Mountains) and Kyrgyzstan (Ala-Too Mountains), we have been able to gather the first-ever photographic evidence of snow leopard presence We completed annual prey surveys, and captured and collared 7 ibex We supported trap camera surveys in China, India, Kyrgyzstan, and Pakistan
