Activities include Bible conferences, Bible studies, Benevolence work, training programs for the destitute in Nepal, helping educate orphans and children in Nepal, medical missions in Papua New Guinea, and evening Church services in Washington.

We helped 35 different churches and ministries plan and facilitate 37 different Bible conferences in 2018. A total of 997 people attended these Bible conferences. During these conferences we provide devotionals, Bible teaching, facilities and meals. Groups that attend these conference come from a variety of churches and ministries which include youth groups, men's groups, ladies groups, family groups, missionaries, leadership groups, and children groups.

We have an interdenominational Sunday Evening Church Service each week along with weekly Bible Studies which are held in various homes and locations. Our Sunday evening service has around 25- 35 people who attend with about 40 people total on a regular basis. We received **\$40,912 in general contributions in 2018 from these Sunday Evening Services which instructions say not to include under revenue since they are contributions. Our emphasis is expository teaching of the scriptures so that men and women have a thorough understanding of who Jesus Christ is and are able to explain to others the gospel of Jesus Christ as taught in the Bible.

We are involved with various ministries and individuals in other countries who are likeminded as we are and are preaching the gospel of Jesus Christ in India, Nepal, Canada, Papua New Guinea, and Poland. Most of our outreach involves the nation of Nepal. Apprx every 4 months we take 10 destitute young woman in Nepal who have had hardly any education and bring them to Kathmandu and send them through a training program so that they become seamstresses and run their own business. We pay for their room, board, and tuition at Rescue Training and Development Center (RTDC). Our 219th student graduated in 2018. We also help street children in Kathmandu, educate orphans, and help some pastors financially. We also supported a ministry in Canada in 2018 called Frontier Lodge who are likeminded in their purpose and faith and a small Bible School in India called Vedanadam Ministries. We help indigent people in our area through a ministry called Cafe Repair which provides help for people in difficult situations with minor car repairs, house repairs, etc. All of these ministries are ran from contributions in 2018 which were \$26676. Instructions say not include this amount under revenue.

Part 1 Line 1 - Every 4 to 6 months a ministry called Rescue Training and Development Center (RTDC) picks 10 young, destitute woman from villages in Nepal that have been recommended by various pastors and brings them to Kathmandu, Nepal. RTDC helps educate them and teaches them how to sew and run a seamstress business. We pay for the room, board, and tuition for those 4 months. During this time they are also taught the love Jesus Christ has for them. At the end of 4 months, they return to their villages to begin their businesses. We are now on our 23rd group of students and have had 220 students graduated with a very high success rate in their businesses. One of our board members travels to Nepal and attends the graduation every 5 months or so and also visits past students and we are in constant contact with the directors of RTDC who send us regular updates and pictures of the students and their progress. www.nepalrtdc.org. We have also involved ourselves with sending some older orphan children whom we have some personal knowledge of to university in Nepal, India and the Philippines by paying room, board, and tuition. Some of these students are from orphanages that we have supported in the past, while others are children of indigent people whom we know personally. These students are also followers of Christ and are committed to sharing the gospel of Jesus Christ. We monitor their progress via email, personal visits while visiting Nepal, and communicating with their parents, pastor or orphanage parents.

Part 1 Line 2 - Frontier Lodge is a ministry in Alberta, Canada dedicated to sharing the gospel of Jesus Christ, using creation as the way to share the gospel with those participating in the programs. Some of the staff at Frontier lodge grew up being part of our Sunday Church services and participated in ministry here. They are likeminded with us in purpose and attended the same Bible School as one of our Board of Directors did. We monitor the ministry through a board member personally visiting the ministry once or twice a year and through emails and phone calls.

Part I, II, III - Selection of Organizations and Individuals we support - The organizations which we select have leadership that agree with our purpose, mission, and doctrinal statements and are followers of Jesus Christ. Someone from our ministry needs to have personally met these leaders. They have not requested grants from us, but rather must be presented to the board by someone from our ministry that knows them. The individual orphans that we pay tuition, room, and board for, have been children in orphanages we have supported in the past or are from indigent families that we know personally. Our emphasis is finding individuals that we know are committed followers of Christ so that the gospel of Jesus Christ will be propagated and disseminated through various avenues of their employment in the future.

Part II - Community Bible School received a large donation of \$240,000. from an estate in 2011 to support our ministries in Nepal. It was decided by the board of directors to invest the money and use the interest from the investment to support our ministries in Nepal. Per our conflict of interest policy a committee of 7 members, (which did not include any disqualified persons or persons with a conflict of interest), unanimously voted to renew the loan of \$120,000. of the money to Greg and Teresa Miller, who are both officers and directors, and the other \$120,000 to Mark and Jill Barrett, Mark being ~~an~~ officer and a director in 2017. The terms of the loans were 5 years, interest at 5%, payable monthly and secured with a first mortgage on a rental property owned by Greg and Teresa Miller and a first mortgage on a building lot owned by Mark and Jill Barrett. All documents were prepared by a lawyer and recorded with Snohomish County, State of WA. Note matures 2/1/2022.

Part III Note* - A son of one of the directors and his wife worked fulltime in Canada at a ministry called Frontier Lodge. Frontier Lodge was founded in 1959 and is like-minded as us, using creation as the means to share the gospel of Jesus Christ to all of those who participate in outdoor adventure programs. In 2018 we sent \$5608 to Frontier Lodge in support of their programs. The money goes directly to the Lodge.

Part IV Note** - Greg and Teresa Miller (husband and wife and directors and officers of Community Bible School) have leased to Community Bible School the facilities that it uses for its Bible Conferences, retreats, and church services for 24 years now. This property is 45 acres, which includes two conference buildings, two single dwelling residences, two one bedroom apartments, meeting rooms, shop buildings, and lake property. The facilities are able to accommodate 60 people overnight with dining and commercial kitchen facilities. The lease in 2018 was \$5657. per month plus insurance and taxes. The current lease expires in 2026. For the convenience of CBS, Greg and Teresa Miller use one of the personal residences located on the property. Total lease including real estate taxes being reimbursed was \$78748. in the year 2018.
