AJS worked with several community-based organizations to support both their external campaign development, and their internal organizational development. In ND, AJS worked with Native Organizers Alliance, Four Directions and the Standing Rock Sioux Tribe to overcome a ND voter ID law blocking many Native people from the polls. AJS and partners worked with researchers at Claremont College, who created maps and identified addresses so tribal officials could issue new IDs to voters. As a result of the unprecedented mobilization work, more than 1460 ballots were cast in Sioux County (compared to 1397 in 2008). In MT, AJS worked with Montana Organizing Project to support their work to inform people about the harms of predatory lending products in the marketplace, while lifting up consumer stories & voices to hold businesses & policymakers accountable to protecting the people. AJS assisted the Work Family Strategy Council with facilitation of a campaign coalition on paid family & medical leave, and supported Citizen Action of NY to build out its NYC chapter & leadership team (see Sched O)

We Are Down Home (NC) does leadership outreach, education & training, and takes action to improve lives. WDH knocked on more than 26,000 doors, & did 169 home visits & community presentations. We organized over 60 trainings involving 755 people. Energy Rates- WDH engaged over 2500 members to defeat a Duke Energy rate hike by testifying at hearings, organizing rallies & online petitions. In June the NC Utilities Commission denied the rate hike, saving families up to \$20/month. Living Wage-WDH members did outreach & education about the issue of living wage in Waynesville. We mobilized 24 members to the town meeting, presented information on the living wage & presented 100 petitions that members had collected in parking lots all over the area. Immigration- WDH stood up for the safety & dignity of immigrant families. We organized 150 people in a public education campaign about why local & state police shouldn't coordinate with ICE to deport families & had over 300 people take action to keep families together. One of our members spoke in solidarity at a rally of 35,000 in DC (see Sched O)

In addition AJS helped the People's Hub develop an organizational strategy and plan for 2019, and worked with Para Los Ninos on an organizational plan and executive transition. AJS collaborated with partners in community and labor organizing on a curriculum, and facilitated a training that provides historic perspective on US social movements, and builds participants' skills and analysis. In addition AJS conducted research and analysis in 3 areas-- one, interviewed 150 leaders in organizing to assess the state of the field and identify promising directions for the future, two, released new living wage data as part of its Job Gap Report Series, and three, completed a case study on the successful, multi-year campaign to win Medicaid expansion in Virginia.

Voting Rights- WDH garnered national press including the New York Times, Washington Post and Huffington Post to raise up the issue of previously incarcerated citizens being denied their right to vote. WDH supported the Alamance 12 by packing the court with over 50 members, and then continued that support during their trial. Syringe Exchange in Canton- WDH opened up a syringe exchange with the leadership of our members in Haywood County. We believe that solving the overdose crisis means caring for, not criminalizing, our loved ones who use substances. Our syringe exchange has provided hundreds of naloxone kits in addition to clean syringes, condoms, and fentanyl drug testing strips. We also mobilized 65 people on International Overdose Awareness Day and 10 volunteers to table at the Recovery Rally in Western NC.
