Community Engagement - Powerful Voices works within the community on girls' issues to promote equity and make the world a more just place for everyone. Community Engagement efforts include producing the annual Girlvolution Conference, providing training on Powerful Voices curriculum and practices, serving on coalitions and partnering to provide outreach to girls detained in King County Juvenile Detention. In 2018, the Girlvolution Conference reached more than 250 youth and adult allies. We also provide trainings to more than 150 girls via external workshops or facilitated when asked by other community-based organizations to provide technical assistance. We worked with nearly 25 volunteers (both youth and adults) to support operations and capacity building. Powerful Voices provided training of up to 20 new Adult Allies (mentors) and served on various community coalitions (like the Coalition to End Gender Based Violence). Powerful Voices staff facilitated education and socio-emotional workshops with 20 girls in detention.

Form 990, Part III, Line 4b:

Case Management - Provides individual with 1:1 support to help students succeed in school, in work, and with family. The goal is ensuring girls experience healthy relationships, can get connected to services and resources to thrive, and have an advocate who can help navigate different systems. The Student Advocacy program served 43 girls.

Form 990, Part III, Line 4c:

Youth Employment Program - Provides girls with pre-employment, career building and job readiness skills. Three cohorts of girls participated in a group employment program that includes individual goal setting and performance evaluation session. The first cohort is Develop Your Voice and Speak (DYVAS), where young women are employed to produce an alternate form of media to educate the community about social justice issues. The second cohort is ActiveVistas, where young women are employed to develop and present workshops at the Girlvolution Conference. The third cohort is Job readiness focused on developing real-world skills through activities such as career panels, resume assistance, mock interviews. The Youth Employment program served 28 youth.
