*Electric utility revenues are generally recognized on the accrual basis, whereby unbilled revenues are estimated and recorded in the period in which they are earned.

During 2018, the Cooperative changed the way it recognizes revenue from the sale of electricity due to a change in revenue recognition rules required by the Financial Accounting Standards Board (FASB). The Cooperative changed from recognizing revenues when customers are billed to recognizing revenues from electric power delivered but not yet billed. As a result of this change, patronage capital as of December 31, 2017 was restated.
