Year 990, Part III, Line 4b:

BOGOTA COLOMBIA // AUGUST 2018 More than five decades after Luis Palau's first major campaign in the heart of Colombia's capital city of Bogota, the Palau Association returned to deliver the same message of hope to a new generation. Hundreds of thousands of people flooded the parks and squares to hear about abundant life in Jesus Christ, and over 18,500 individuals publicly placed their trust in Jesus. The 3-day festival was a fitting capstone to the historic campaign that united 852 churches and reached more than 200,000 people in person through multiple events in the city. In the weeks leading up to the massive festival, the Palau team and local leaders coordinated multiple outreaches, including gatherings for women, business and civic leaders, children, and prisoners. Each festival day featured top Christian musicians, testimonies from actors and international business leaders, and a clear message of hope and faith in Jesus Christ from Andrew Palau. "It was such a privilege to be standing in the same square where my father started so many years ago, Andrew Palau said. "To be sharing the same Good News Gospel, in the same city, among the same wonderful people--it was a dream come true. I was born in Colombia, when my parents were missionaries there. I have a deep passion for the people of Colombia. I love this nation. And I pray all of Colombia would come to know Jesus as their Lord and Savior." The goal of the campaign, just like all Palau festivals, was to shake the nation with the Gospel and help launch the Church into a powerful new season of evangelism and outreach. As part of this vision, the Palau team gathered hundreds of younger evangelists from several nations throughout Latin America for a time of in-depth training, encouraging, equipping, and inspiring. The festival helped foster unity within the Church, made evident through the two pastors' gatherings held in the lead-up to the festival, which included more than 12,500 leaders from throughout Bogot and the surrounding area.

MEXICO CITY, MEXICO // MARCH 2018 God moved in a mighty way in Mexico City this year as Andrew Palau and the team joined with hundreds of local churches to share the Good News of Jesus through the Marcha de Gloria Festival. After more than a year of preparation, planning, and prayer, the festival culminated in the largest and most well-known plaza in the center of Mexico City. El Zocalo. Tens of thousands of people came to the festival and participated in the preceding parade. During the weekend, Andrew also spoke at a conference for pastors, evangelists, and church leaders, inspiring and encouraging them in their calling. In total, more than 3,000 people documented a confession of faith in Jesus Christ because of the festival in Mexico City.

SAO PAULO, BRAZIL // MAY 2018 For more than 26 years, God has used the evangelical church in Brazil in a powerful way through the March for Jesus Festival. Each year, hundreds of thousands of individuals gather together in the city to worship the Lord and proclaim His Good News. This year, Andrew Palau was invited to be the special guest evangelist. He addressed the massive crowd on the final night of the festival and shared the life-saving message of Jesus. Hundreds of thousands of individuals participated in the event, making it one of the largest gatherings of its kind in the region. Organized by the local evangelical community and supported by hundreds of local congregations, the event built on the foundation of 25 years of similar marches and rallies. This gathering in Sao Paulo grabbed the attention of the entire continent and brought the Gospel to millions through the live event and surrounding media. Focusing his message on John 10 10--"The thief comes only to steal and kill and destroy, I have come that they may have life, and have it to the full"--Palau ended his message with a clear call to faith and repentance. The sea of hands that raised in affirmation of his call was evidence of the impact of the Word. Andrew went on to implore those who had publicly confessed Jesus Christ to dig into Scripture, get their roots deep into a local church, and pursue God daily. Also during the Palau Association's time in Brazil, the team gathered with local pastors, church leaders, and evangelists, encouraging them in the Word, focusing on enduring unity, and inspiring them to keep evangelism a top priority.

JOSE C. PAZ // NOVEMBER 2018 God accomplished great things through the most recent campaign in Jose C. Paz, Argentina. We're rejoicing over God using this festival to share the Good News with more than 50,000 people in person and through media efforts. The festival proved to be a truly blessed Gospel moment for the Church and the nation of Argentina. "It was a joy to return to Dad's home country-- where his story began, where God first called him to sharing the Gospel on the streets of his hometown, Andrew Palau said. "Back then, Dad faced consistent opposition when he first started preaching, but there's been a dramatic change in receptivity in recent years. Dad says he never imagined Argentina would be so receptive. But it's true! Years of prayer are bearing fruit and we saw a great harvest in Jose C. Paz. It was a privilege to share this message of hope with a new generation. to tell those hurting of the true, abundant life that only Jesus can provide. Organized by the local evangelical community and supported by 140 local church congregations, the festival built on decades of committed ministry in Latin America from the Palau Association. A highlight of this festival was a beautiful service project earlier in the week in partnership with Samaritan's Feet. Focusing on the children of the community, the Palau team hosted a gathering on the Thursday before the festival where disadvantaged and underprivileged children could get their feet washed and receive a new pair of shoes. As the volunteers washed the children's feet, they shared the Gospel with them and invited them into a relationship with Jesus Christ. As a result of that outreach alone, 76 children accepted Christ. We're expectant of how God will continue to work through the unity, partnership, and excitement initiated by this campaign. Because of our work together, we were able to lift up Jesus Christ in Jose C. Paz and lay the groundwork for years to come.

Form 990, Part III, Line 4c:

MEDIA Since its inception, the Luis Palau Association has taken the message of the Gospel to the airwaves through evangelistic radio and television programs. Today, our impact in the world through media has expanded to include continent-wide radio and television broadcasts, best-selling books, a massive Internet presence, multiple social media channels, digital evangelism strategies, and online training courses for pastors and evangelists throughout Latin America. And that's just the beginning. In 2018, we also participated in a bold new film project. A Christian production company began production of a feature-length film on Luis Palau's life and ministry. The dramatic retelling of Luis' early life and ministry was finished in December and Palau The Movie is scheduled to release in hundreds of theaters in North and South America in April. Luis also began work on a powerful new book in 2018, Palau A Life On Fire, which is scheduled to release in June. Tracing his faith journey from humble beginnings on the streets of Buenos Aires, Argentina, to sharing the Good News on global stages, Luis shares a rare glimpse into the details and individuals God used to shape him in his spiritual journey.

INSTITUTO BIBLICO LUIS PALAU The Luis Palau Association has spent the past 6 years developing and launching a powerful online training curriculum designed specifically for Spanish-speaking pastors and church leaders. Working with several strategic partners, this online Bible Institute has grown to become a valuable training resource for leaders throughout the Spanish-speaking world. This Bible Institute now offers more than 112 training hours that maximize five decades of ministry experience from more than 25 top Christian leaders, all free of charge. Future goals include expanding training modules to better equip and encourage evangelists, and expanding online curriculum to include training for women in leadership.

PALAU LINK CENTER 2018 also saw the completion of the new Palau LinkCenter, a co-working space for like-minded nonprofits to share space and resources in spreading the Good News and having greater Kingdom impact. It all started in 2016 when the Palau team asked itself, "What would Godly stewardship of our building look like?" We knew we could do more with the space and resources God had given us. The LinkCenter is already serving 20 ministries with additional space for others. Project goals for the future include blessing smaller and newer ministries with the many resources and networks that Palau has gained over the years, and to encourage and collaborate with like-minded ministries for greater reach for the Gospel.

CITY GOSPEL MOVEMENTSBuilding on the success we have experienced through this initiative over the past several years, we plan to focus our attention between now and 2020 on expanding our partnerships with leaders across North America to celebrate and accelerate sustained City Gospel Movements in hundreds of cities. Goals include inspiring more city movements by sharing success stories and lessons learned, promoting the best evangelism ideas and resources for city transformation, and developing a successful City Gospel Movements Marketplace strategy to better connect marketplace leaders who can actively engage in citywide evangelistic strategies.

NEXT GENERATION ALLIANCEThe Palau Association's Next Generation Alliance (NGA) was formed to identify, affirm, equip, and mobilize an international fellowship of evangelists. In 2018, this fellowship grew to 750 members. Under the motto "One Message, Many Expressions," NGA members use many means and methods to proclaim the Good News of Jesus Christ--including festivals, neighborhood outreaches, action sports, music, creative arts, multimedia and the Internet. As we look toward the future, NGA will continue to focus on providing practical training and resources on critical ministry concerns through the NGA website, conference workshops, five annual webinars, MIF (Mission Increase Foundation) training and resources, and four new strategic partnerships with other evangelism training groups. SUNBURY, ENGLAND // JUNE 2018While the United Kingdom seems to be at an all-time low in Christian population and regular church attendance, a number of unified, area-wide evangelistic campaigns this year gave a different picture of the state of the Church in the British Isles. One of these events, Joy@Kempton Park with Andrew Palau in Sunbury, England, engaged the entire community in the effort, regardless of religious background. The event--first dreamt up by local pastor Rowena Cross--involving nearly half a dozen ministries, more than 15 local churches, and hundreds of Christians. The festival was focused on sharing the Good News in an area where so many people had yet to learn about Jesus. The event saw more than 2,000 people converge on the Kempton Park Racecourse to enjoy the family fun, music, and a message of Good News from Andrew Palau. Along with the evangelistic outreach, a practical service project dubbed "Love Sunbury" helped take the message to the community as well. Included in the effort were neighborhood clean-up projects, home revitalization projects, and a massive "feeding of the 5,000." "Only God could have done this," Cross said. "At every opportunity God provided us with what we needed--sometimes before we even knew we needed it. We had no money, no budget, nothing. It's about going beyond what we're capable of doing as humans." This appears to be the beginning of a new season of ministry and outreach for the United Kingdom. While in England the Palau team met with dozens of leaders in a handful of cities. From Birmingham to Wolverhampton, Bristol to SW London, each group had the same desire--to see the Church come together to proclaim the Good News on a massive scale in their community.4 CITIES TOUR // OCTOBER 2018The Palau team traveled throughout the U.K. in The 4 Cities Tour to unite with pastors and leaders who are passionate about pointing their communities to Jesus, and interested in beginning preparations for future evangelistic festivals. Additionally, Andrew shared the Good News with many who had never heard the Gospel. Four cities and 8 evangelistic events, helped launch an evangelistic movement in the region. The team traveled to Edinburgh, London, Bristol, and Birmingham, encouraging and uniting hundreds of faith leaders, speaking to local media and in churches, and building relationships with local business and civic leaders. Highlights of the trip included joining with more than 120 key national leaders in London as part of the U.K.-wide initiative for evangelists called Advance 2020 to hear the vision and strategy of the movement, a powerful night of worship and prayer with hundreds of people, and the beginning planning meeting between Wendy Palau and Lady Susie Sainsbury for a women's outreach in May 2019. The visit also began the discussion with leaders in the area about hosting a region-wide evangelistic festival in 2020. Additionally, Andrew joined with musicians Martin Smith and Daughters of Davis for a powerful night of worship and a message of hope. The 4 Cities Tour was a perfect opportunity for believers to invite their friends who needed to hear the Good News. "It was inspiring to see a historic Anglican building have so much vibrancy and enthusiasm," UK Director Dave Plowman said. "Around 200 people attended and many made decisions for Jesus."

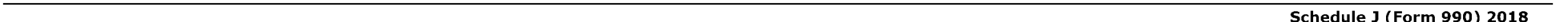
