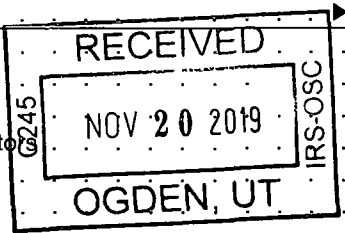

Part III: The organization's primary exempt purpose is to assist the old, sick, undernourished, and undereducated peoples of Buddhist Asia, and to help preserve the ancient Buddhist heritage and culture of Tibet.

Part III, Line 31: Other program services include \$2600 for general support of monastics holding vows of poverty; \$5187 to ransom the lives of 57 yaks in Tibet so that these animals can live out their lives in peace, while supporting Tibetan nomadic families with milk and hair (they will now not be slaughtered for meat or used as beasts of burden); \$450 for support of monastics holding vows of poverty to conduct meditation practices for the benefit of all beings; and \$300 for prayers and meditation to be done for a deceased person by monastics holding vows of poverty.
