BOOK BUDDIESDuring summer months when students do not have access to their school libraries, McMinnville Public Library is reaching out with its bookmobile to bring books and activities to underserved neighborhoods. The children are excited to meet the bookmobile when it comes, receiving free books, borrowing books, participating in STEAM (science, technology, engineering, arts and math) projects, and maintaining their energy with healthy snacks. The team offering these services comprises both paid library staff and volunteers. Funding for this program comes from the Foundation's annual fundraising letter. Foundation assistance includes paying for personnel and supplies costs. The board has made Book Buddies an ongoing part of its support for the library, as it does with Collection Enhancement. For 2018, Book Buddies took the bookmobile to three different neighborhoods once a week for 10 weeks, two hours per visit. This outreach served 1,132 program participants and 773 bookmobile visitors.

In practice, the Library Director actively participates in and contributes to the agenda of Foundation meetings, weighs in on the amounts of money the Foundation spends on library needs and largely defines those needs. The Director spends part of each meeting reporting to the board how library programs have performed with the Foundation's annual draft budget, in concert with the Foundation's treasurer. Except for the fact that the Library Director does not have a vote, she is as actively and materially engaged in the Foundation's business as any other board member. The Foundation and the Library Director are each an integral part of the same undertaking. |
