

990EZ Part III, Line 28 Marine Conservation & the Ocean Environment

Conservation advocacy for marine biodiversity and the resilience of coastal communities. We conduct public education events, support two grassroots groups involved with Oregon's nearshore marine reserves (Cape Falcon MR & Cascade Head MR). Our work is conducted by Coast Range Association staff person Jim Carlson. Our Marine Program directly serves the people of Lincoln, Tillamook and Clatsop counties. During 2018 we completed an assessment of scientific literature on how climate change may impact the coastal ocean. We provided \$19,500 in funding for video production addressing coastal recreation and the ocean environment.

990EZ Part III, Line 29 Private Lands Forest Management

Public interest research and advocacy for sustainable forest management. Coast Range Association staff person, Chuck Willer, spoke at fourteen community events presenting research on private forest ownership, taxation, industrial management practices and other issues related to the long term sustainability of private forestlands. The organization's work serves the populations of 21 counties in Western Oregon. We provided Mary Scurlock \$12,000 in funding to support her work on stream protection rules with the Oregon Board of Forestry.

990EZ Part III, Line 30 Public Lands Management

We continue our long advocacy addressing the conservation of native forest and the protection of aquatic values on federal lands. This work focused on upholding several key federal laws regarding land management planning by the BLM. We believe the agency erred in

developing its Western Oregon land management plans for five districts. Consequently, we went into federal court to argue our claims.

Earthjustice and Western Environmental Law are our attorneys. To date we have lost two decisions by federal judges. The case is now

before the 9th Circuit Court of Appeals in Portland, OR.
