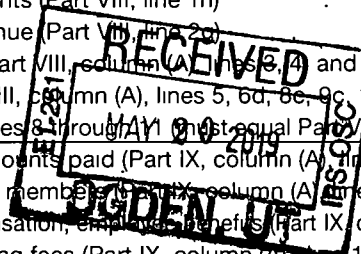

Print run of approx. 1100. Subscribers: 750 approx (which include schools, libraries, teachers and families) & many on-line users. Skipping Stones content is carried by several full-text websites for educational and library users. The magazine content is also used in both print and online standardized tests, and by some print and online publishers

we also held two honor award programs to recognize multicultural awareness and nature education in juvenile literature, as well as in teaching resources. The Youth Honor Awards program promotes creativity in children and youth, and serves kids and educators. The Skipping Stones Honor Awards program recognizes books and teaching resources that promote multicultural and international awareness, and/or nature understanding. There were approximately 260 entrants but the program benefitted all educators and readers of Skipping Stones as well as other educators and general public.

Educational reading material for low-income schools, libraries, families and organizations serving low-income youth. This program sends free and discounted subscriptions, free back issues of our magazines and / or donations of books to about 125 schools and libraries, near and far. Also some discounted subscriptions for low income families. The revenues for this are general donations and small grants received from supporters and local foundations.
