OHSA's Charitable Checkoff Grant program is funded through the Oregon Charitable Checkoff Commission. The Commission is charged with approving charities to receive donations from taxpayer designated refunds. OHSA offers funding on a grant basis to Head Start programs, primarily for projects relating to safety and health, such as playgrounds, wheelchair ramps, and roof repairs. Money is generally granted in the fall for projects that occur the following Spring and Summer. Programs are prevented from receiving funds two years in a row to ensure more equitable distribution of resources. Funds in 2018 were awarded to--Eastern Oregon Head Start repairs to aging outdoor equipment, \$1,285.00--Head Start of Yamhill County automatic gate for the bus parking area, \$4,826.00--KidCo outdoor classroom, \$5,500.00--Klamath Family Head Start bus safety restraints, \$8,166.81--Mid-Willamette Valley Community Action Agency outdoor art and music area, \$10,642.87--The Childrens Learning Center security system, \$6,426.00--UCAN playground structure, A/C, window screens \$8,258.89
