The GALA study is an international effort to pool together available data sources to conduct a comprehensive analysis of an international cohort of patients with ALGS in order to determine the prevalence, natural history, social economic burden, patient outcomes, with a focus on extra hepatic manifestations. By pooling together available data sets, we will increase the understanding of ALGS and identify unique challenges and needs our patient population.
