WE DONATE NEW STUFFED ANIMALS TO POLICE AND FIRE DEPARTMENTS AND MEDICAL ORGANIZATIONS FOR POLICE OFFICERS, FIREFIGHTERS, AND MEDICAL PERSONNEL TO GIVE TO CHILDREN IN CRISIS. THE GOAL OF HUG PATROL IS TO PROVIDE EMERGENCY RESPONDERS THROUGHOUT THE PACIFIC NORTHWEST AND EVENTUALLY THROUGHOUT THE NATION WITH A SUPPLY OF NEW, UNUSED STUFFED ANIMALS TO HELP EASE THE PAIN AND FEAR OF CHILDREN IN TRAUMATIZING SITUATIONS.
