28 Project H E R This program continued to provide free health services (Help, Enlightenment, and Resources) in Benton, Linn and Lincoln counties of Oregon The Navigator program provides awareness, education and support for patients from the time of cancer diagnosis through survivorship, with the Navigator team, which consists of a nurse navigator, outreach coordinator, and cancer survivors who mentor patients free of charge with the guidance of the nurse navigator The Project H E R navigator provided support for 170 cancer patients in 2018, and there were 18 active mentors during the year The Cook for Cancer program served 1,728 meals for 128 families of patients who were undergoing chemotherapy treatments of all types of cancer diagnoses, oncology and hematology Project H E R sponsored several support groups Breast Cancer Support Group (averaging 6 attendees monthly), GYN Cancer Support Group (averaging 11 attendees monthly), and Blood Cancer Support Group (averaging 5 attendees monthly) A Cancer Education Day (which provided free education and resource connection for cancer patients, family members, caregivers, health care providers and community members, featured keynote speakers, a vendor fair with cancer resources, and survivor networking) was held on September 29th with 225 participants, presentations at the free event included Immunotherapy What your T-Cells Can Do For You, Is Food Our Cure?, Treatment of Breast Cancer Past, Present, Future Directions, and Human Genetics 101 Project H E R personnel also participated in other outreach events to increase awareness of cancer prevention and Project H E R support, including (1) facilitation of "Look Good Feel Better" classes through the American Cancer Society (42 women attended), (2) partnership with Pink Sistass, Inc to provide a breast cancer retreat (8 women survivors attended), (3) sponsorship and tabling at the Soroptimist International Walk for the Cause event on October 6, (4) attendance at the Breast Cancer Issues Conference on March 17, (5) participation at Melanoma Walk at Corvallis High School on June 3, and (6) provided support at numerous Dam Cancer (Pink Out) fundraising athletic events held at the local university and high schools In addition to \$56,290 of cash expenditures paid for programming and outreach (which includes \$40,035 paid for a leased employee and \$500 for grants), \$71,318 of donated meals, services and facilities were received in 2018 for Project H E R programs (Grants \$ 500) If this amount includes foreign grants, check here . . . ☐	28a	57,600
