The association achieved a record-setting 6 3% increase in membership with a 92 2% retention rate, due in part to member-driven programs like the California Physician Career Center on the organization's updated website, a new monthly membership program, and a new student loan refinancing member benefit

Form 990, Part III, Line 4b:

In 2017, CMA protected the self-governance rights of hospital medical staffs-the physicians-led entities responsible for the quality of patient care in hospitals. CMA has been assisting the physicians of Tulare Regional Medical Center (TRMC), where medical staff is engaged in an unprecedented legal battle with hospital administrators. This lawsuit poses an "existential threat" to medical staff and physician independence, and is critically important to protect medical staff self-governance rights and the physician-patient relationship. The case stemmed from actions taken in 2016, when the TRMC board of directors voted to terminate its medical staff and create a new medical staff bylaws in secret without input from physicians at the hospital. TRMC dictated leadership and standards of medical care, seized control of the disciplinary process without legal or factual justifications, and prohibited the terminated medical staff from voting on medical staff matters or holding leadership positions. CMA strongly believes medical decision-makers should be insulated from influence by hospital administrative staff, whose primary concern is the administrative needs of the hospital and its profitability. CMA filed a pre & post trial amicus briefs in this case, provided financial support, and organized fundraising from medical staffs and the American Medical Association to the CMA Legal Defense Fund for the case. Because of this case, CMA has increased the capacity of the legal defense fund to protect or establish important legal rights of physicians to practice their profession and assure high-quality medical care. In 2018, helped TRMC restore independence and self-governance against the hospital. This victory and the publicity surrounding the hospital re-opening led to an increased on Organized Medical Staff Section membership to over 90 hospitals.

In 2018, California Medical association recouped nearly \$11 million from payors on behalf of the organization's physician members, in addition to fighting health plan and insurer policies that that delay, limit and prevent access to care, including contracting with fewer physicians, limiting choice for patients and increasing wait times for referrals
