VARIOUS OTHER PROGRAM ACTIVITIES THE BLUE DEVILS C CORPS IS A BEGINNING-LEVEL MUSIC, DANCE, AND MARCHING ACTIVITY COMPRISED OF MEMBERS FROM CALIFORNIA. THE MUSIC PERFORMANCE GROUP CONSISTS OF APPROXIMATELY 70 STUDENTS AGES 8-14. THEY PERFORM IN PARADES AND FIELD COMPETITIONS AROUND CALIFORNIA. THE DIABLO WIND SYMPHONY REINFORCES SCHOOL MUSIC PROGRAMS AND OFFERS OUTSTANDING MUSICIANS A CHANCE TO PERFORM MAJOR BAND REPERTOIRE AT A HIGH LEVEL. IT SERVES 60 TO 80 LOCAL STUDENTS AGES 14-22, OFFERING CONSISTENT INSTRUMENTATION CONDUCTIVE TO PERFORMING MAJOR WIND AND PERCUSSION COMPOSITIONS. DESIGNED AS A COOPERATIVE INTERACTION WITH SCHOOL MUSIC PROGRAMS, THE DIABLO WIND SYMPHONY OFFERS A POSITIVE LEARNING ENVIRONMENT, MASTER CLASSES WITH PROFESSIONAL CLINICIANS, AND AN ANNUAL CONCERT SEASON WITH INTERNATIONALLY RENOWNED SOLOIST. ACTIVITIES INCLUDE ENSEMBLE REHEARSAL, MASTER CLASSES, SECTIONALS, AND A VARIETY OF SMALL GROUP ACTIVITIES FOR THE MORE ADVANCED STUDENTS.
