 Valuescience - taught "Valuescience: Shedding Illusion to Live Better" to more than 500 people in seminars and meetings at Magic, Stanford, and other local venues; revised seventeen approximately thirty-minute valuescience audiovisual presentations, converted them to videos, and uploaded them to YouTube; presented Silicon Valley Barcode of Life (one of several dozen initiatives world-wide to catalog and track changes in biodiversity using DNA sequencing of specific small genome regions) in five academic, two corporate, and ten community settings; organized a Silicon Valley Barcode of Life bioblitz at Hidden Villa where sixty-five volunteers collected over 400 arthropod samples to be DNA barcoded and added to BOLD, the publicly accessible International Barcode of Life Database.  
 Residential Education - guided forty-nine residents from fourteen countries and fourteen states within the United States of America in creating valuescience-based service-learning community.

Part III, Lines 4a, 4b, and 4c: Magic's programs are integrated, particularly our value-science based, service-learning community. We've allocated expenses to reflect labor expended by personnel (Magic is operated entirely by volunteers) as well as cash and in-kind outlays net of grants. We allocated 60% expenses (excluding grants) to Valuescience, 25% to Cooperation and Individual Well-being, and 15% to Environmental Stewardship.

Part VI, Line 11: At the annual meeting where board members and officers are elected, members of Magic's Board of Directors receive estimates of the financial information and drafts of the program descriptions to be entered on Form 990. Board members receive quarterly or when requested more frequent reports of program and activities and finances. Directors are given opportunity to review completed Form 990's before they are submitted. They are informed that Magic also submits Form 990, California Exempt Organization Annual Information Return, to the California Franchise Tax Board, and Annual Registration Renewal Fee Report to the Attorney General of California and offered opportunity review these if they choose. All information on these forms is taken directly from Form 990 and its attachments.

Within a week of the annual meeting, Magic officers and key personnel also sign an identical statement as described above.
