To this end, we sponsor regional, national, and international conferences, webinars, and briefings, as well as publish research geared toward both funders and the broader public. HIP's network is large and growing: our membership includes 59 foundations and nonprofits, as well as many individuals across the U.S. and Latin America. Finally, HIP's comprehensive leadership programs aim to strengthen the pipeline of Latino leaders and increase diversity in the nonprofit and philanthropic field. HIP's Leaders program provides targeted professional development and networking opportunities for mid-career social sector Latino leaders, and has served 128 individuals.
