Technology Services includes database development and maintenance, technology planning, the Plan IT cohort-based program, and IT Infrastructure services. By the end of the year we were maintaining the IT Infrastructure of 89 organizations, including providing rapid assistance through our Help Desk. Data Solutions began offering intranet development services, including board portals. Our IT Director served as a part-time IT strategist and consultant to large nonprofits. Five organizations participated in the 2018 Plan IT action learning program. They worked with two skilled volunteer consultants to assess their technology and develop a plan for improvement. Technology is critical to staff productivity and the ability of nonprofits to communicate, raise money, and deliver quality programs. We advocate to "ZaptheGap" between nonprofit and for-profit access to technology, calling on foundations and businesses to address the technology needs of nonprofits.

Form 990, Part III, Line 4b:

In 2018, we served over 137 organizations of various sizes with financial services and consulting. Services provided include accounting and bookkeeping, best practices consultation, and tax filings. By providing these services at affordable rates, our clients are able to focus on their mission and have the financial data they need to make sound management decisions.

Form 990, Part III, Line 4c:

Members of the Executive Services Corps worked on 93 management consulting projects. They also served in several action-learning programs to cohorts of organizations: Springboard (for arts and cultural organizations), Catalyst for Fundraising Success, and Volunteer Manager Corps (temporary pro bono volunteer managers to build volunteer management systems). In 2018, 21 organizations participated in Pathways. In Pathways, organizations complete the Five Elements of a Healthy Nonprofit self-assessment and work with two consultants to understand how they can improve their performance on the 58 standards in the assessment. Nonprofits receive detailed recommendations with the survey results. The Information and Referral Program handled nearly 464 cases, helping people find service providers and resources, solve problems, and determine their best course of action. Website information and resources were accessed by 75,907 users.
