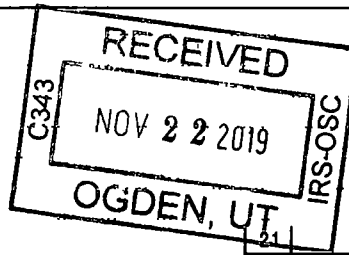

STATEMENT 1

TAXPAYER IS CLAIMING A DEDUCTION FOR AMOUNTS REQUIRED, PURSUANT TO ALASKA STATE STATUTE, TO BE USED FOR SPECIFIC PURPOSES. PURSUANT TO ALASKA STATUTE 05.15.150, A COPY OF WHICH IS ATTACHED, THE NET PROCEEDS OF THE CHARITABLE GAMING ACTIVITY, AFTER AWARDING PRIZES TO CONTESTANTS, ARE TO BE DEDICATED TO POLITICAL, EDUCATIONAL, CIVIC, PUBLIC, CHARITABLE, PATRIOTIC OR RELIGIOUS USES IN THE STATE. FURTHER, PURSUANT TO ALASKA STATUTE 05.15.170, AN ORGANIZATION'S CHARITABLE GAMING PERMIT MAY BE SUSPENDED OR REVOKED FOR FAILURE TO COMPLY WITH ALASKA STATUTE 05.15.150.

THE TAXPAYER BELIEVES THAT THE REQUIRED USES OF THE NET PROCEEDS ARE ORDINARY AND NECESSARY EXPENSES WITHIN THE MEANING OF INTERNAL REVENUE CODE SECTION 162. THE REQUIRED USES OF THE NET PROCEEDS ARE ORDINARY AND NECESSARY BUSINESS EXPENSES INsofar AS THEY ARE REQUIRED UNDER ALASKA LAW FOR RETENTION OF THE CHARITABLE GAMING PERMIT. THE PERMIT IS REQUIRED UNDER ALASKA LAW IN ORDER TO CONDUCT THE PULL-TAB ACTIVITY. THE REQUIRED USES OF THE NET PROCEEDS ARE ALSO IN THE NATURE OF AN ANNUAL RECURRING LICENSING EXPENSE.

THE TAXPAYER BELIEVES THAT THE FACTS OF ITS SITUATION, AS STATED ABOVE AND SUPPORTED BY THE ATTACHED ALASKA STATUTES, ARE VERY SIMILAR TO THE FACTS IN "IN RE: SOUTH END ITALIAN INDEPENDENT CLUB, INC. V. COMMISSIONER, 87 TC 168."
