Helping children and families by supporting and funding organizations such as Make A Wish Foundation, Supporting the Taylor House and Tommy Apostolos Fund. Make A Wish Foundation is on a mission to create a life-changing wishes for children with critical illnesses. We awarded \$7,760 to Make A Wish Foundation to participate in the Adopt-A-Wish program to sponsor a wish to a child in our community. Supporting the Taylor House is a home for girls who emancipated from foster care with little or no family support with a goal to empower independence by teaching essential life skills and offering affordable rents to transitioning foster girls ages 18-21. We have granted \$5,000 to Supporting the Taylor House to fund the ongoing program and to assist in opening a new home. Tommy Apostolos Fund supports the underserved and struggling children of Roseville by providing with clothing, shoes, school supplies and other essentials. We have granted \$5,000 to Tommy Apostolos Fund to fund the annual children shopping spree.

Providing health and mental health services by supporting and funding organizations such as Community Recovery Resources, JDRF and Keaton's Child Cancer Alliance. Community Recovery Resources operates with a vision to reduce the social, health and economic impact on families and children from all types of substance abuse by serving nearly 2,000 people each month with a full spectrum of prevention and treatment services. We awarded \$5,000 to Community Recovery Resources to fund their programs. JDRF is the leading global organization funding type 1 diabetes (T1D) research. JDRF is on a mission to accelerate life-changing breakthroughs to cure, prevent and treat T1D and its complications. We have awarded \$5,000 to JDRF to fund research and treatment of T1D. We granted \$5,000 to Keaton's Child Cancer Alliance to support their effort in providing children with cancer and families with emotional, educational and financial support while increasing awareness and funding research toward a cure.

Providing hungry, homeless and disaster and crime victims by supporting and funding organization such as Placer Food Bank, River City Food Bank and St Vincent de Paul of Roseville. Placer Food Bank is dedicated to feeding the hungry through network of partner agencies, educating the community about hunger and advocating for hunger relief. We granted \$5,000 to Placer Food Bank to support their Fill the Pantry drive. We have awarded \$5,000 to River City Food Bank to fund their Empty Bowls hunger awareness campaign and to provide funds for programs and operations to feed the hungry. St Vincent de Paul of Roseville provides basic human services and programs to prevent hunger and homelessness. We have granted to St Vincent de Paul of Roseville \$5,000 to fund their ongoing services and programs.
