OUR PROGRAM PROVIDES THAT OPPORTUNITY, SUCH THAT IN 2017 SERVICES WERE PROVIDED TO NEARLY 2,100 YOUTH/YOUNG ADULTS WHO PARTICIPATED IN QVOLUTION GROUPS MEETINGS AND ACTIVITIES AT THE CENTER. THIS PROGRAM OFFERS YOUTH DROP-IN, DURING WHICH TIME YOUTH HAVE ACCESS TO THE DAVID BOHNETT CYBER CENTER THAT IS POWERED BY COX, A POOL TABLE, VIDEO GAMES, TELEVISION AND ARTS AND CRAFTS. A SNACK CLOSET IS MADE AVAILABLE THROUGH SUPPORT AND A PARTNERSHIP WITH THREE SQUARE AND OTHER CONTRIBUTIONS.
