Activities include workshops, leadership and professional development activities, educational programming, mentoring, counseling, referrals, fieldtrips, and more. About 350 youth participated in support groups and/or drop-ins this year

Youth gain skills and experience developing and implementing projects at Stonewall Youth and in our community. There's a wide range of projects, from creating educational handbooks for schools to painting murals. Youth also engage in work in all areas of our organization, including organizational development and program development/implementation. Others do outreach and workshops at schools and other venues. 10 youth participated and about 500 youth and other community members benefited

4c (Code) (Expenses \$ 22,638 including grants of \$ 0) (Revenue \$ 11,937)
Along with regular weekly support groups and drop-in hours, we have at least two other activities and events each more. Some of these are safe/sober social events for LGBTQ youth, such as open mics, youth performances, or dances. Others are community events, such as art shows, open houses, workshops, panels and much more. Youth work with adult staff to organize and conduct these events. All events further our mission and assist us to do outreach to LGBTQ youth.
