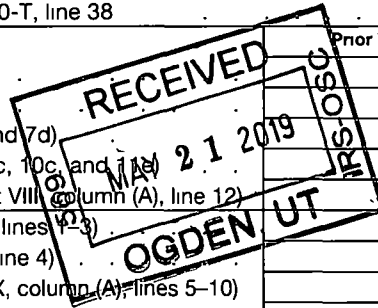

Our programs & services engage young students in powerful learning across the curriculum, empowering teachers and scientist & engineer volunteers to plan and implement exciting STEM learning experiences. We connect teachers with regional science, engineering, and environmental education resources.

 BASIS and Be A Scientist. Engaging STEM professionals as volunteers in local K-8 schools  
 The CRS STEM education in-class programs recruited, trained, & placed more than 650 STEM professionals to serve as mentors and role-models and to lead students in science and engineering learning activities and investigations. Over 16,000 Kindergarten through 8th grade students directly interacted with scientists and engineers who inspire students to learn about academic and career options in science and engineering. BASIS lesson plans, lesson materials, resource information, science content background, and teaching strategies are shared with classroom K-8 teachers to encourage pre- and post-visit explorations. Lessons are archived and available on the CRS website. Be a Scientist program engages scientists and engineers to mentor middle school students through process of designing, conducting, and reporting on independent student-selected science and engineering investigations.

 Teacher Services: CRS provides more than 1,700 kindergarten through 8th grade teachers with comprehensive information, research, personalized support, web based resources, training, workshops, and other support related to science teaching and learning. CRS served classroom teachers in 140+ schools in the East Bay including Oakland, Emeryville, Berkeley, and West Contra Costa. CRS provided teachers with on-call planning support, custom research reports, and responded to hundreds of individual teacher requests. CRS provided workshops addressing science and engineering teaching practices, content, curriculum, and new science standards. Together, the teachers we serve educate over 43,000 students, mainly in high-need, under-resourced urban schools. Through our Science Super Star Challenge, we recognized about 100 teachers for excellence in elementary science teaching, awarding prizes such as field trips, assemblies, books, and classroom supplies. Information services include comprehensive online resources, month email bulletins, quarterly resource reports, newsletters. We hosted two free teacher events in partnership with local science centers, connecting teachers with a range of support organizations and educational service providers, and highlighting resources such as field trips and in-class programs. CRS engaged 300 educators in professional development.

 Resource Development: Convening, consulting, and training projects targeting challenges and opportunities in K-8 science education. CRS provided professional development and curricular development services to schools, districts, and informal education organizations. CRS coordinated site-based projects, facilitated teacher professional learning, connected resource partners, and shared information regarding best practices in STEM education. The CRS Advisory Council on Elementary Education brings together thought leaders from industry, academia, school districts, informal education organizations, scientists, engineers, teachers, and others working to improve K-8 science education. CRS provided NGSS aligned training, information, and professional development for teachers at both school and district levels. Through regional and national conferences, CRS shares our program service models, our expertise in preparing scientists and engineers for education outreach, and our education resources. CRS is part of the 100Kin10 national STEM education network, the regional Gateways East Bay STEM Network, among others. CRS serves on the Alignment Bay Area STEM ecosystem network, convening regional partners to address needs in STEM teaching, learning, and mentorship.
