At WTMF, we emphasize the importance of philosophy, together with practicing martial arts. In our view, the philosophy we teach corresponds to human mind and practice of martial arts corresponds to human body. Our body cannot function without our mind. Based on this understanding, WTMF offers lectures on philosophy to all participants of our events. We invite students of martial arts from many schools to our events to share our philosophy with them and work together to start building a better world. We had 13 events worldwide in 2018 with the aim to achieve our objectives outlined above. Some were solely sponsored by us and others were co-sponsored by our associates. The following is the list of the events:
