BEST COMPANY, AN INSURANCE INDUSTRY RATING AGENCY. THE CREDIT UNION RECORDS A LOAN RECEIVABLE AT THE LESSER OF THE CASH SURRENDER VALUE OF THE POLICY OR THE LOAN AMOUNT PLUS ACCRUED INTEREST. AS OF SEPTEMBER 30, 2018 AND 2017, THE BALANCE OF THE LOAN TO THE EXECUTIVE UNDER THIS ARRANGEMENT WAS APPROXIMATELY \$3,791,000 AND \$3,775,000, RESPECTIVELY.
