The Adventist Health Glendale Foundation provides a fundraising function to support the mission of Adventist Health Glendale and programs to improve the quality of life and health in our community. The funds are transferred to the hospital based on the grantors and donors intent. A significant portion of Management and General expenses are paid for by Adventist Health Glendale and accounted for as a department of the hospital in its support of the Foundation. The following story illustrates how the Foundation is able to support the mission of Adventist Health Glendale and believes it is a miracle in the making. We did the biopsy, it was positive. I told her the results but by then it (the tumor) was metastatic. We both didnt know how much time she had. Linh Chen, MDDr. Chen, Medical Director of Radiology at Adventist Health Glendale, remembers the mother of a nine-month-old boy and two other children, all under five, who was her patient. During the mothers most recent pregnancy she had developed a lump in her breast. She was nursing, and so she had extremely dense breast tissue, Dr. Chen recalls. We had done a mammogram and ultra sound, but we never saw anything concrete. Following the birth of her baby, the mother came in for a follow-up. By then she had stopped nursing for a while. At that follow-up we saw a small area in what you would call an architectural distortion. Dr. Chen explains that the hospitals technology is digital mammography, similar to traditional mammography, but the image is captured on a computer. For a 2-D image, which we had been using, everything is superimposed on each other, so normal tissue can easily hide a small cancer. The new 3-D technology is called digital breast tomosynthesis. Images show thin slices through the breast so each slice can be studied more precisely for any signs of cancer, however small. Thats why its such a better tool, Dr. Chen says. Adventist Health Glendale is a Breast Center of Excellence and participates in the ACR American College of Society Registry for Mammography. Our statistics are extremely good, but I think with tomosynthesis it can be even better, Dr. Chen told an audience in a video shown to more than 600 guests at the Healthcare Foundations 2018 Gala. I am doing the best that I can for my patients, but I am limited by technology. Guests watched in stone silence as Dr. Chen continued her story on screen of the mother with three young children. We did the biopsy, it was positive. I told her the results. She had more studies to work up, but by then it (the tumor) was metastatic. I remember the day she came by to tell me. It was just heartbreaking. She showed me her sons picture, how shes trying to spend as much time with him as possible. We both didnt know how much time she had. Throughout the ballroom, eyes welled up, tears flowed. Pausing to gather her emotions, Dr. Chen concluded, Looking back I think if we had the tomosynthesis equipment, it would have allowed us to see that subtle area of architectural distortion earlier before she got pregnant even, to catch the cancer at that time. It would have saved her, saved a family. Gala 2018s theme was Dream. What occurred following Dr. Chens presentation wasnt a dream, it was reality. The generosity of a community of donors, through their contributions of more than \$300,000 to the Healthcare Foundation, made possible the hospitals acquisition of the latest, technologically advanced 3-D mammography system. Today, three-dimension mammography is now helping Dr. Chen and other physicians detect invasive breast cancers too small for 2-D mammography to spot them. Having this potentially life-changing equipment available on the Adventist Health Glendale campus is an amazing gift to the greater Glendale community. Compassionate, high-quality patient care, life-saving and life-preserving medical and surgical services, advanced treatments in a community-based hospital, essential emergency services-these are the reasons our donors choose Adventist Health Glendale as their charity of choice.
