Outreach and Education Program: efforts were directed primarily to rural communities of Costa Rica's upper Balsa River watershed. Nectandra Institute worked closely with a consortium of local community water management associations to improve the watershed's forests and water resources, to co-organize and sponsor the 9th annual "New Culture of Water" Month. Through this annual festival, Nectandra Institute and our community partners attempt to build public awareness for watershed protection through a series of educational, recreational, and entertainment activities and events. Approximately 40 educational activities took place during the year on topics such as conservation, ecological restoration, and environmental stewardship. Outreach efforts also included online videos, slides presentation and dissemination of information.

Conservation and Advocacy Program: Efforts continued on lands totaling 611 acres purchased by local community organizations with eco-loan assistance from Nectandra Institute. During 2018, we coordinated over 2000 person-hours of restoration and monitoring work, including tree plantings, measuring tree growth, monitoring the volume of water flowing from springs and in streams, and systematic photo-documentation of forest restoration progress over time. Conservation of lands acquired to date thanks to Nectandra Institute's eco-loans has helped improve the protection for the sources of drinking water for 16,000 people. Additionally, conservation work continued on over 40 acres of tropical cloud forest owned by Nectandra Institute. Nectandra Institute also participated in the inter-institutional commission for the Paso de las Nubes biological corridor, which exists for the purpose of strengthening biological connectivity between Costa Rica's Juan Castro Blanco National Park for Water and Alberto Manuel Brenes Biological Reserve.

Research and Citizen Science Program: With assistance from volunteers from Costa and abroad, we continued monitoring stream water quality at 24 different sampling points within the upper Balsa River Watershed. We also continued with our amphibian monitoring project, which relies on the participation of the public to report sightings of frogs, toads, salamanders and other amphibians in order to create and maintain a record of the distribution of amphibian species in Nectandra Institute's geographic program area. Inventory work on the flora of the Nectandra Cloud Forest Preserve also continued.
