The high quality material appeals to amateur and advanced hobbyists, nurseryman, academic botanist and everyone in between. The CSSA has published the Journal since 1929. Recent back issues can be purchased and older volumes can be purchased on DVD.

Haseltonia is the technical yearbook of the Cactus and Succulent Society of America. It is published in full color and features peer-reviewed articles about all aspects of Cactus and Succulents. Serious students of succulent flora, botanist, taxonomists, researcher and horticulturalist will find Haseltonia a valuable addition to their book collection. Back issues are available.

The CSSA is building a library of specialty books. We currently have two books the "beginners Guide to Gasteria, Haworthia, agave, and other Succulent Monocots" by Tom Glavich and "Aloes of the Cactus and Succulent Journal 50 years of descriptions. More books are planned.

The CSSA holds a Convention every other year where members enjoy talks by leading speakers from all over the world. Attendees go on tours to notable cactus and succulent locations in the area. They have the opportunity to purchase rare and unusual plants from vendors. The 2019 Convention will be held in San Jose, CA on July 17-20, 2019.
