

CIFOR continues to lead the CGIAR program on Forests, Trees and Agroforestry (FTA) - the world's largest integrated collaborative research program on forests and trees. The program provides core collaboration with other CGIAR Research Programs and centers, and partners. CIFOR is engaged in two other CGIAR programs - in the IFPRI led Policies, Institutions, and Markets and the CIAT-led program on Climate Change, Agriculture and Food Security.

In 2018, Research Support Units supported CIFOR's research programmes by providing state-of-the-art technical services, library facilities, computer services, systems development, and electronic communications.

In 2018, CIFOR scientists based around the world produced a total of 385 publications, of which 80% are open access. The publications include 22 books, 59 briefs, 30 chapters, 25 occasional and working papers, 156 journal articles and 93 others. Our publications were downloaded nearly 1.6 million times, with over 10,000 citations and 350,000 Google book visits  
The Global Landscapes Forum (GLF) is in full momentum with a reach of 250 million people, inspired by the collective enthusiasm of researchers, indigenous groups, policy makers, private companies and a growing youth movement, all working to find landscape-based solutions to the world's most urgent environment and development challenges.
