During 2018 PREF continued to sponsor programs related to its mission of nurturing peace within individuals and relationships, as well as promoting connectedness among groups in the larger community on Hawaii Island. The teaching and promotion of meditation as a practice leading to personal growth and transformation continued to be a major focus of PREF's activities. Thus PREF held a four week program on Passage Meditation & Spiritual Development, a program on Centering Prayer Meditation, and a program entitled "An Evening of Peace," featuring meditation, a silent meal, and the showing of the film "Walk With Me" about a Zen Buddhist master whose community practices the art of mindfulness. PREF also continued to sponsor periodic interfaith meditation programs, a monthly program providing education on Contemplative Prayer, and an interfaith Memorial for the Tree of Life Synagogue victims. PREF, also in 2018, continued with its interest in promoting personal health as a component of a peaceful lifestyle, hosting a weekly "Short Forms for Long Life" Tai Chi program led by Jinan Wong, a gifted teacher from an ancient lineage. A second area of focus for PREF involves holding programs on days designated by the General Assembly of the United Nations as having particular significance. For example, the UN has designated September 21st of every year as the UN International Day of Peace, and June 21st as the International Day of Yoga. Each of these designations is intended to promote the ideal and substance of peace and PREF sponsored in 2018 programs supportive of these goals. These included a Yoga program on June 21st featuring yoga teachers from different traditions, and a seven day LovingKindness Prayer program which ended on September 21. Each of these programs represented Hawaii Island's participation in the global celebrations held under UN auspices. Recognizing the importance of interfaith relations in any community, PREF nurtured programs in 2018 that have helped its Hawaiian Queen Coffee Garden location develop into an interfaith center used by individuals and groups of different spiritual traditions, and have seen it emerge as the primary interfaith center in Kona and on the Big Island.
