These Executive Directors acknowledged that their current compensation did not reflect the value that their services/expertise might demand in the for-profit industries, but that it did reflect the reality of the non-profit budget and mission work to which they were each personally committed. A similar regional organization Hanalei Watershed Hui has one on-staff expert who is paid at the same rate or more than the E D and at Waipa Foundation, at least three other key employees are paid between 25 to 27 per hour. Given this regional data, Hale Halawai Ohana O Hanalei's current compensation of 70,000 salary per year for the Executive Director is aligned with regional compensation of similar positions in similarly sized organizations in related work.
