The medical program provided Medical Care to approximately 2000 patients in the city of El Catey, Dominican Republic and the surrounding communities. We hosted one medical missionary team with volunteer medical providers. We have a Dominican national medical doctor volunteering in our medical clinic. She is providing nutritional and physical activity counseling as well as general medical care services. The sports and community outreach program hosted a Dominican church that used the facility for community evangelism. The sports program organized and directed a summer baseball league for 40 youth in El Catey and hosted baseball tournaments for neighboring communities. The sports program initiated an umpire training program for young men and women living in the area.
