By coming together to share their stories, patients and their families, as well as those who have lost loved ones to ALS, find strength and support with one another. Walks to Defeat ALS create an environment of empowerment where families and friends of persons with ALS are given an opportunity to affect public policy by signing petitions that are sent to the legislators representing their districts. Walks also bring awareness to local communities of those fighting ALS and of the support available to them through The ALS Association Golden West Chapter. The Golden West Chapter's Public Policy and Leadership Development program is intended to increase understanding, education and awareness of the devastating impact of ALS and the role that The ALS Association plays in achieving the three core components of our mission, Care Services for patients and families, global research for treatments and cures, and important Public Policy initiatives. Through these efforts, we engage volunteers in the communities we serve and give them the opportunity to participate in advancing the activity of the organization and the achievement of our mission priorities. This program also encompasses the California ALS Research Summit, an annual gathering of researchers, investigators, clinicians, biotech companies, government representatives and patient advocates in ALS and related fields in the State of California. The purpose of the Summit is to help increase, expedite and promote the amount and level of amyotrophic lateral sclerosis and related research done in California, and to foster networking, collaboration and cooperation among investigators, their peers and their colleagues to identify, develop and deliver new and effective treatments, ideas and, ultimately, cures. This expense category also includes \$1.2 million dollars representing a pledge that was written off due to a change at the national office that did not align with the donor's intent. This is categorized herein as bad debt.

Chapter care services staff members are embedded in each clinic, where they act as key members of the multidisciplinary team and provide comprehensive support to persons with ALS and their family members/caregivers. This model of care brings together a team of health care professionals specially trained to address the needs of people living with ALS, allowing them to receive care from each discipline during a single visit. The care team typically includes a neurologist, physical therapist, occupational therapist, respiratory therapist, nurse, dietitian, speech language pathologist, social worker, mental health professional, and an ALS Association chapter liaison. The ALS clinics supported by the Golden West Chapter provide compassionate care in a supportive, family-oriented atmosphere. In addition to supporting established clinics, the Golden West Chapter supports and promotes satellite clinics that improve access to critically needed services provided within this proven multidisciplinary, wraparound model of care.

To ensure that progress is being made and to allow for program modifications if necessary, a six month progress report is required of all grantees. A year-end report confirms the impact of the grant and creates the platform for the application for renewed funding. To receive clinic support, the ALS clinic must be in the state of California and must maintain and adhere to the national standards of Certified Treatment Centers of Excellence (CTCEs). The standards require a multidisciplinary team approach, a cornerstone of the wraparound model of care. Compliance is monitored through on-site clinic participation by chapter staff as well as compliance monitoring by The ALS Association national office. CTCEs must submit an annual report to the national office. Once the national office reviews and confirms adherence to CTCE standards, the CTCE is awarded funding to support clinic services for one year.
