The attendees teach the other commissioned officers of the agency in regard to what learned.

children to purchase approved clothing, shoes, toys and games for themselves and their families. The participants are provided by local charitable organizations who certify that the children qualify for federal assistance programs

\$11,940 was donated to fund the attendance of two commissioned officers at the University of Louisville's Southern Police Institute where the officer received training in the latest

law enforcement theories and techniques for fighting the evolving nature of criminal activity. The Association funds the tuition, books and supplies, and the per diem expenses and travel expense for the officers to attend the program with Washoe County absorbing the wages and benefits that accrue to the officers during their time of attendance. Upon return the officer share their experiences with their co-workers and the public in a effort to impart the benefit of their attendance to such audiences.

\$9,400 was donated to the Washoe County Sheriff's Office to purchase equipment an supplies of the agency's Mounted Horse and K-9 Units as well as paid the costs for providing the 24-hour meal service to employees of the agency and their families required to work on Thanksgiving, Christmas and Easter holidays.
