HBF directors maintain a close and continuous working relationship with today's HUB Manager and Senior Staff through twice yearly HBF Board of Director meetings, the Manager and Senior Staff attending and contributing their views, more frequent committee meetings, HBF's directors committees include and consult with their student counterparts for Alumni Relations, Investments and the like) and numerous casual contacts between Directors and undergraduates at HUB performances. Additionally, the music directors of the HUB attend HBF Board meetings, provide reports and consult frequently with the board of directors.

IV, D, 3: Aside from its operating overhead, the HBF spends no money from its funds for anything other than the grants as specifically requested by the HUB, thus ensuring that the HUB has a significant voice in directing the use of the HBF's assets. The HBF's investment policies are structured to provide ongoing, reliable resources for the purposes proposed by the HUB.

IV, E, 2A: The HBF has no independent undertakings or Board-selected projects. We fund specific activities and underwrite the specific costs of our one and only supported organization, the HUB. Examples include the repair and purchase of musical instruments, uniforms, office technology and sound recording equipment, along with the costs of travel to performance venues and the securing of rights to perform specific compositions. Every grant request is scrutinized by the Grants committee prior to funding and must be found to be in keeping with the HUB's mission as a student performing organization.

IV, E, 2b: But for the HBF's funding of specifically requested needs of the HUB, as identified by the HUB, the HUB would have to spend its own money on all and the same expenses. ABD would have to engage in the same fundraising, donor cultivation, and investing the HBF performs to make these funds available.
