The Commission provided grants of up to \$2,000 to approximately 305 Elk Lodges to facilitate programs that support veterans, active-duty military members and their families. Elks used these grants to provide food and clothing for homeless and hospitalized veterans, hold adaptive sports events for veterans with disabilities, repair the homes of military families and veterans in need, support student veterans and more.
