In addition, the Committee reviews benchmarking data, including comparable survey data from the Council of Engineering and Scientific Society Executives (CESSE), the Georgia Society of Association Executives (GSAE), the American Society of Association Executives (ASAE), and other relevant data, including a survey conducted by the American Research Company on non-profit executive compensation, which IISE participated in. Relevant comparisons are drawn in the following categories: overall, southern region, 501(c)(3), budget size, staff size and tenure in the position. This data is provided to the Personnel Committee between December and February. The Committee members meet with the ED in February to discuss the matter. These discussions
