Endowment funds are established by donor-restricted gifts and bequests to provide a permanent endowment which is to provide a permanent source of income to the ACLUF. The ACLUFs endowment investments are bound by the terms of the Trust for the Bill of Rights agreement, in which the Uniform Prudent Management of Institutional Funds Act ("UPMIFA") is interpreted to require the preservation of the fair value of the original gift as of the gift date of the donor-restricted endowment funds absent explicit donor stipulations to the contrary. As a result of this interpretation, the ACLUF classifies permanently restricted net assets as (a) the original value of gifts donated to the permanent endowment, (b) the original value of subsequent gifts, if any, to the permanent endowment, and (c) accumulations to the permanent endowment made in accordance with the direction of the applicable donor gift instrument at the time the accumulation is added to the fund. The primary long-term financial objective for the ACLUFs endowments under the terms of the Trust for the Bill of Rights Agreement is to preserve the real purchasing power of the endowment assets and income after accounting for endowment spending, inflation and costs of portfolio management. The endowments are managed to optimize the long run total rate of return on invested funds, assuming a prudent level of risk. The goal for this rate of return is one that funds the ACLUFs existing spending policy and allows sufficient reinvestment to grow the endowment principal at a rate that exceeds inflation. At times, the fair value of assets associated with these endowment funds may fall below the level that the donor requires the ACLUF to retain as funds of perpetual duration. These deficiencies result from unfavorable market fluctuation. In accordance with U.S. GAAP, deficiencies of this nature are reported in unrestricted net assets. At March 31, 2019, there were no such deficiencies reported. The Trust for the Bill of Rights has an agreement that states that the total amount to be distributed to each unit share shall be 6% of the average of the Fair Market Value of each unit share of the Fund for the three preceding calendar years. The ACLUFs Board of Directors then has the option to reinvest this or to take it for the operations of the Organization. The ACLUF endowments at March 31, 2019 are all permanently restricted.
