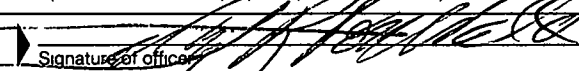

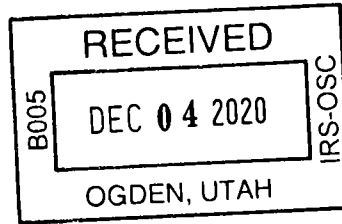

The explanation for the incorrect filing of Schedule A, Part III, Support Schedule for Organizations Described in Section 509 (a) (2) is multifold. I inadvertently filed using Part II, Support Schedule for Organizations Described in Sections 170 (b) (1) (A) (iv) and (vi). The numbers in Section A, Public Support and Section B, Total Support were correct, but unfortunately on the wrong form. Under more normal circumstances the 990-EZ would have been reviewed by a CPA prior to submission. However, due to COVID-19 restrictions, we were not able to complete this step where the error would have been corrected prior to submission to the IRS. I was confined to my home due to the suggested stay at home regulations put out by the Government due to COVID-19. In addition most businesses were also asking us to stay at home too. In an effort to have an on-time filing of the original 990-EZ, COVID-19 forced us to use a undesirable protocol for the filing.

We (SLHC, Inc) are a small charitable organization, manned by unpaid volunteers, who support Law Enforcement and Fallen Police Officers. Thank you for considering our explanation. We ask that NO PENALTIES be assessed as no tax is owed and we were unfortunately struck by how the COVID-19 virus hampered us in providing a correct and timely filing of our 990-EZ and supporting schedules.
