**Equipping the Church**  
At the core of ServeNow is assisting local congregations in remote areas and in slums. This includes providing churches with bibles and pastors/ministry leaders with training in a series of discipleship literature over 7-10 years, so they can systematically instruct their congregations. 147,000 Basic Series discipleship books were printed, and over 80,000 distributed to pastors, leaders and congregation members. 32,025 Basic Series discipleship booklets and other Scripture literature were distributed among churches in India and 856 leaders were trained through conferences. 10,000 Basic Series books were distributed to six major churches in Ukraine to go out to smaller branch churches. 45 pastors, with no other means of transportation, were provided bicycles to travel throughout Uganda to their churches. 3,701 Basic Series books were studied in Uganda among 215 churches in 374 villages. 4,468 New Testaments were also distributed in Uganda. 100 leaders benefitted from Leadership Training in Uganda. 60 churches in Nepal (5,850 people) received 40,000 copies of Basic Series discipleship books and various other Scriptures/literature were distributed. Most of these pastors and leaders do not have access to literature that helps them understand the foundational truths of Christian faith.

The related payable to Mountainbrook Press will be paid as Basic Series books are able to be printed at \$.10 per booklet until the debt is satisfied. Current balance of payable is \$117,604.

"Sharing Christ's passion for the world by serving the most vulnerable through national churches and leaders."

The Salvation Army Humanitarian Aid receives medical, handicap, and personal equipment from hospitals, community centers and companies. We have written agreements with counties, communities and private companies regarding their equipment. When we receive different items, the hospital establishes the price for each piece of equipment. Depending on its prior use, we discount those prices up to 40%. There are stringent rules regarding comfort, standard and durability, both from EU and Swedish authorities. All items received and then passed on to ServeNow are cleaned, renovated and in full working condition. Medical machines, etc., are checked by technicians from the donating hospital. As an extra control, we value each major piece of equipment, with matching age, from other groups like Ebay.

**Improving People's Lives (formerly Children and Youth Programs)**

ServeNow works with disadvantaged children, orphans as well as street children in centers located in a major slum in Kolkata, India, and one in Kathmandu, Nepal. In India a school from Kindergarten to Grade 4 is in operation; in Nepal, children are tutored, as well as taught life values through teaching, drama, music, crafts, games and other activities. 60 children benefited from this center in India and 160 children received ongoing tutoring in Nepal. Across India 3,795 children were also reached with children materials in their own language. ServeNow helped fulfill Sunday School/VBS programs for 600 children. ServeNow also operated two summer camps for 175 children in Ukraine. During the school year in Ukraine, 94 students participated in meetings which addressed topics related to health, human trafficking, safety, freedom, and critical thinking skills to develop habits to protect them. Through the completion of a new school building in Uganda, 167 additional children are now able to receive an education. 71 children were sponsored on an ongoing monthly basis in Uganda. ServeNow operated several tailoring schools as well as cosmetology schools and bakery classes to train young women in a trade in order to avoid being drawn into trafficking. 60 women received vocational training/counseling in India. 5 students were trained in Ukraine in cosmetology. Two women learned to be hairdressers, and three pursued masters of nail service. They all have successfully completed the course and four of them have already found jobs and are providing income for their families. Four students in Ukraine received bakery lessons and have graduated. 125 women in Nepal went through the tailoring program, graduated and have started jobs or their own businesses and 22,500 women were educated in human trafficking awareness and child labor issues by the women who received tailoring training.

**Part III Statement of Program Service Accomplishments, Line 4c**

**Outstretched Hands (formerly Humanitarian programs including containers)**

ServeNow provides day medical camps, with national physicians and nurses, seeing approximately 150 patients a day. 1,701 patients were able to receive medical treatment and prayer at medical camps in India. An additional 1,000 people were treated via special medical clinics in response to bad flooding. In the summer when drinking water is scarce, clean water is provided during the worst months for individual families in remote communities, villages or slums. 600 people who do not have access to clean drinking water during the hottest months in India were provided water. In areas where it gets freezing cold and children and elderly have no winter coverings, we provide winter clothing in remote villages and in slums and mosquito nets in areas where many of the recipients otherwise may become gravely ill from malaria. 2,000 people received winter clothing and blankets in India and Nepal. 400 mosquito nets were provided for children and families to protect

from malaria during the worst monsoon season in Nepal. ServeNow also provides container loads of humanitarian aid such as medical equipment, wheelchairs, clothing and furniture for under-equipped hospitals and disabled people. Six hospitals, organizations and various individuals received roughly 750 items altogether, including wheelchairs, walkers, medical equipment and other materials. Another container was shipped with more items for those in need. ServeNow gave 4,880 Christmas gifts to adults and children from disadvantaged families, both in the war-torn area of Ukraine, as well as other parts of the country, as a token of love. Short term teams provide additional needed staffing for a variety of humanitarian and other ministry programs. It also allows individuals to have a life changing experience by spending two weeks in international settings, working alongside nationals in humanitarian projects. Team members may also assist national doctors and nurses in medical camps as well as providing free drinking water in areas where no water is available. Some other areas involve taking part in summer camps for orphans, physically challenged and refugee children. Four teams with 28 people total went on a ServeNow trip.

**Ministry Coordination**

ServeNow maintains operational offices in several locations in India, Sweden, Nepal, Ukraine. These offices coordinate the projects in each of their respective areas. ServeNow provides ministry, leadership, and project support for these offices as part of its program services. This support allows the national leaders to hire competent national staff, which thereby also supports the local community in these countries.

Management sends the draft 990 report to the entire board of directors by email at least two weeks in advance of its filing, requesting their review and comments. Directors "reply to all" by email, so the whole board and top management can track the discussion and any concerns or corrections.
