

SAFE is a subrecipient of an HUD/CDBG grant from the City of Thousand Oaks, CA to fully manage a project for the rehabilitation of mobile homes within 5 of the City's senior mobile home parks The program benefits very low and extremely low income elderly and aged and is utilized for high cost maintenance far beyond the means of the targeted demographic Maintenance includes new roofs, energy efficient windows, heating and cooling system and electrical repairs Significant energy savings, health, safety and general quality of life results from this investment in our seniors SAFE provides detailed surveys, conducts interviews, creates scopes of work, collects bids for work from licensed and insured contractors, bill City against work done, pays contractors, provides independent inspections SAFE complies with HUD regulations, title 24 and all its applicable references to other titles SAFE maintains its books according to GAAP and utilizes the Uniform Chart of Accounts for nonprofits Sixteen (16) homes are included in this project Only 4 homes remain to be done Weather slowed the progress of work, therefore, the project is still unfinished SAFE received 1/2 of its admin fees with the balance due upon completion in June 2019

This HUD/CDBG grant is simply another annual grant as described above Twenty seven (27) senior mobile home owners will benefit from this active grant Again, SAFE is under contract with the City of Thousand Oaks, CA as the grant subrecipient with total responsibility All participants have been selected and advertisements for bids will be issued on May 30, 2019 for this extended program Again, the demographics are very low and extremely low seniors consisting of Veterans who gave up income earning years to serve our Country and women who had been systematically prevented from high income careers due to the customs of their generation In both cases this demographic must exist on meager social security payments Again, this is a restricted grant so no monies are paid by the City until the work is done However, both SAFE and contractors may be granted payment for work in progress SAFE is on an accrual basis so admin charges sit in receivables until work is completed or a progress payment is allowed Beneficiaries are very low and extremely low elderly and aged seniors Revenues are in receivables and will not be paid until completion planned for December 2019

GENERAL SAFE volunteers donated 1,236 hours in fiscal 2018-19 adding \$37,018 in value to its grants and services SAFE received an unrestricted private grant to provide small dollar assistance to the extremely low income seniors such as a new screen door, lever operated door handles, railings and grab bars for safety This grant is also used to provide durable medical equipment (DME) to those who cannot afford these devices They include, walkers, rollators, wheel chairs, transport chairs, bath chairs, bath transfer benches, portable commodes, canes, crutches and such This grant also allowed SAFE to help a Korean war veteran rid his home of termites and to replace a leaking bedroom window with a new "E" window for a 93 year old WWII Veteran SAFE provides newsletters and information to the senior demographic SAFE volunteers provide rides to doctors and grocery stores for those without transportation SAFE volunteers also provide food and company for the disabled and shut ins

Senior Alliance For Empowerment, (SAFE) is a subrecipient of an HUD/CDBG grant through the City of Thousand Oaks, CA. SAFE is contracted to manage all aspects of their portion of the grant.

Detailed records are recorded and maintained by SAFE in accordance with HUD regulations, 24cfr and all related laws and regulations. Subject grant was for 145,000 with an allowance of 8%

to cover administrative costs. This grant is restricted and is for the specific purpose of rehabilitating mobile homes occupied by very low and extremely low income elderly and aged seniors

who cannot afford high end maintenance such as new roofs, HVAC and energy efficient windows. The grant allows these financially stressed seniors to remain in their homes in a healthful and

safe environment without the fear of being forced from their homes. SAFE conducts complete surveys of the target mobile home parks to determine the needs of the residents. SAFE's Board

selects recipients based upon income, health and safety, disabilities and age. The needs far exceed the available funding. SAFE follows HUD guidelines plus to establish eligibility. SAFE collects

3 bids from qualified and licensed contractors. SAFE bills the City when work is completed and inspected.

For 2019, SAFE received in July 2018 a contract for 200,000 with 10% allowed for administrative costs. Because SAFE uses accrual accounting, the grant is recorded as a receivable. However, no monies will be transferred and no work will be done until SAFE's fiscal year beginning April 1, 2019 and as such the details of this grant will be reported in the 2019-2020 fiscal year.

SAFE is a 100% volunteer nonprofit charity without payroll or compensation of any kind for its officers and volunteers. SAFE volunteers donated 878 of their volunteer hours to subject grant.
