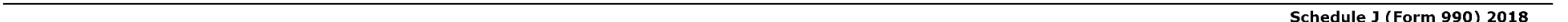

In such a case the Trustee will have an opportunity to be heard. However, in the event that a Trustee is asked to resign, they should respect the majority decision and resign at the earliest opportunity. All employees at a senior management level (international or national) are required to produce a declaration of relevant interests, particular in circumstances where they may be involved in the procurement of goods or services, or decision making, where a conflict of interest may impact on the decision.
