Schedule R - Additional Information

The organization shares certain facilities and equipment with the PGA of America. PGA Corporation is the direct employer for most of the related organizations and the organization shares some of these employees. PGA of America holds the general disbursement account for most of the related organizations. This general disbursement account is used for cost savings, efficiencies, and is not for purposes of paying bills for related parties who do not have enough liquidity to pay their own expenses. PGA of America disburses funds for expenses of the PGA Foundation. The PGA Foundation reimburses PGA of America for these disbursements on a periodic basis.
