ANY THAT WERE HAPPENING WOULD HAVE TO BE FIT IN WHEN THE CARDIOLOGY CATH LAB WAS NOT USING THEIR FACILITIES. IF FACILITIES WERE NOT AVAILABLE, PATIENTS WOULD HAVE TO BE TRANSFERRED TO A DIFFERENT COUNTY TO HAVE THEIR PROCEDURE DONE AND TRANSPORTED BACK TO THE HOSPITAL. THE NEW LAB WILL DECREASE COSTS ASSOCIATED WITH TRANSPORTATION, LENGTH OF STAY, AND REDUCE RISKS DUE TO QUICKER RESPONSE TIME. THE NEW MACHINES IN THE LAB ARE MINIMALLY INVASIVE ALLOWING FOR QUICKER RECOVERY TIMES THAN LAPAROSCOPIC SURGERY. AN INTACT BREAST BIOPSY SYSTEM WAS PURCHASED FOR THE BREAST CENTER THIS YEAR. IT HAS THE ABILITY TO REMOVE AN ENTIRE LESION IN 1 TEN SECOND PASS. IT USES RADIOFREQUENCY ENERGY TO SEPARATE TUMORS FROM NORMAL BREAST TISSUE, OFTEN WITH NO BLEEDING. IT ALSO ALLOWS FOR DEFIBRILLATIONS TO OCCUR DURING COMPRESSIONS WHICH CAN IMPROVE THE OUTCOME OF CARDIAC ARREST PATIENTS. THIS YEAR THE EMPLOYEE ASSISTANCE FUND GRANTED 5,268 TO EMPLOYEES FACING UNEXPECTED OR EXTRAORDINARY FINANCIAL CIRCUMSTANCES.
