PAN works to build health, justice and resilience in our food and farming system. As one of five PAN Regional Centers worldwide, we link local and international consumer, labor, health, environment and agriculture groups into a citizens' network that challenges the global proliferation of pesticides, defends basic rights to health and environmental quality, and works to ensure the transition to a just and viable food and farming system.

Core programs: PAN has campaign activities in four key agricultural states, as well as national and international programs. Our state campaigns in California, Hawai'i, Iowa and Minnesota use coalition organizing, strategic communications and grassroots science to raise public awareness about pesticide harms and build momentum toward a healthier food and farming system. In 2018-2019, our successes included 1) winning new rules in Hawai'i to protect schoolchildren and communities from pesticide drift, including buffer zones around sensitive sites and a ban of the brain-harming pesticide chlorpyrifos; 2) mobilizing farmers, beekeepers and community members in Minnesota to promote pollinator protections and challenge state preemption of local pesticide rules; 3) building momentum for national and international-level support for farming as a climate change solution, including mobilizing farmer support for the Green New Deal and organizing PAN International promotion of agroecology in UN fora.

Coalitions: PAN builds network power through strategic alliances with other public interest organizations. Our campaign work with network partners often leads to creation of formal coalitions for which PAN acts as facilitator, administrator and/or fiscal sponsor. One of our fiscal sponsors is the Toxic Taters Coalition in Minnesota, a coalition of community groups, farmers and indigenous organizations who are directly impacted by pesticides drifting from commercial potato fields, and it was a key partner in this year's core program work. Another sponsor, Californians for Pesticide Reform which has over 190 member groups, participated in the successful effort to ban chlorpyrifos in California. Through our PAN Fellows program, PAN supported the California Farmer Justice Collaborative and the Protect our Kelki coalition in Hawai'i, and PAN continues to participate in coalition work in Colorado, Oregon, Maryland and nationally. In 2019, PAN served as a fiscal sponsor to more than 20 allied organizations that do not have 501(c)(3) status and we had the pleasure of seeing one of those groups, People and Pollinators Action Network in Colorado, "graduate" to 501(c)(3) status in its own right.
